Jersey Law Course Prospectus 2010-11

The Jersey Law Course provides structured tuition in a supportive environment, delivered by experienced academics and local practitioners, for candidates intending to sit the qualifying examinations to become Jersey advocates or solicitors. The course, or some modules from it, will also be of interest to other law professionals who want to acquire knowledge of one or more areas of Jersey law. The course is flexible and part-time, designed to fit around students' employment commitments. Most face-to-face tuition will take place over weekend study sessions. The course may be taken either in one year or spread over two or three years.

How to apply

As soon as you think you may be interested in the Jersey Law Course, please complete and return an **expression of interest form** (download from www.lawinstitute.ac.je) so that we can keep in touch with you.

Once you have decided to start the course in 2010, please complete and return an **application form** along with a deposit of £100 and a passport size photograph. The closing date for applications is **Friday 6 August 2010**. The first instalment of fees is payable on 27 August 2010 (see under 'Fees', below).

Who may apply

The Jersey Law Course is primarily intended for lawyers who will, having passed the examinations, be eligible to become an advocate or solicitor in Jersey in accordance with the Advocates and Solicitors (Jersey) Law 1997 and the Advocates and Solicitors (Qualifying Examination) Rules 1997, as amended. Everyone in this category is guaranteed a place. The relevant legislation can be found at <http://www.jerseylaw.je/LawStudents/Legislation/default.aspx>. Specific queries about eligibility to qualify as a lawyer in Jersey should be addressed to the Chairman of the Board of Examiners (the Deputy Bailiff, via R.Traisnel@gov.je or telephone 01534 441103) rather than to the Institute.

Particular modules (or indeed the whole course) may also be of interest to lawyers and other professionals with substantial legal experience who, while not intending to qualify as a Jersey advocate or solicitor, want to acquire knowledge of Jersey law. If you fall into this category you may, if you wish, sit examinations in the modules you take or, if you prefer not to take the examinations, you may ask for a certificate of attendance.

Start

The course begins in the first week of September with an induction event. This will include a lecture on an area of Jersey law, distribution of the study guides for the first semester, an introduction to the virtual learning environment (see below), a briefing on the examinations, and an opportunity to meet tutors and other students. The study weekends start in early October, giving you a chance to read through some of the study guides and prepare for the first seminars.

Duration

The whole course may be taken in a single academic year or spread over two or three years. The 1-year, 2-year and 3-year programmes of study all require a substantial investment of personal study time outside the study weekends and other classes; for students taking the course in a single

year the work load is particularly intense. The draft calendar at the end of this prospectus gives an idea of the frequency of study weekends. Individual modules are taught either in the first semester (September to December) or second semester (January to May).

Syllabus

The Jersey Law Course is based on the curriculum determined by the Bailiff, in consultation with the legal profession (<http://www.jerseylaw.je/LawStudents/Syllabus/syllabus.aspx>). There are five core papers.

- Jersey legal system (including the history of Jersey law, its sources, customary law, the writers on Jersey law and the relevance of Norman customary law and English common law) and constitutional law
- Law of contract and the law relating to security on movable property and bankruptcy
- Testate and intestate succession
- Law of immovable property and conveyancing
- Civil procedure and criminal procedure

In addition, candidates must take one of the following options:

- Company law
- Trust law, or
- Family law.

Study weekends

For each module, there will be two weekends (three in the case of the Law of contract and the law relating to security on movable property and bankruptcy). These will generally be seminar-style sessions, in which you will be required to participate actively, having prepared in advance by reading the study guide and the materials available on the virtual learning environment.

The timetable for a typical study weekend will look something like this, though there will be some variation between modules:

Friday: 5.00-7.30 pm seminar (with short break in the middle)

Saturday: 10.00-12.00 pm and 1.00-3.00 pm seminars, followed by opportunities to consult the visiting or adjunct professors on a one-to-one basis

Sunday: smaller group tutorials, with students signing up for either a 9.00-12.00 pm class or a 1.00-4.00 pm class.

Students taking the whole course in a single year will have study weekends as follows:

The 3-year programme enables students to select a pattern of tuition and examinations to suit their particular needs. If the course is being taken for the purpose of qualifying as an advocate or solicitor at least two papers must be taken in each year.

Additional classes may be offered. The course includes 10 hours of tuition in French for conveyancing.

Study guides

A detailed study guide has been developed by the visiting and adjunct professors in each module and approved by the Board of Examiners. These are updated every year. You will receive printed versions of each guide in ring-binders. The study guides provide an up-to-date and systematic account of each area of law and clear guidance on what is and is not covered by the syllabus for each module. Those for the first semester will be distributed at the September induction session to give you a month to read through the material before formal teaching starts. Study guides for the second semester will be distributed at the beginning of December.

Virtual learning environment

Once you have enrolled, you will have access to a virtual learning environment (VLE). This is accessible from any PC or laptop connected to the internet by logging on with a username and password at <http://www.lawinstitute.je>.

There is an area of the VLE for each module on which you will find copies of the key cases, legislation and other material. The main teaching sessions are video or audio recorded and these are uploaded to the VLE for students who may want to listen again to discussion on a particular topic. A forum enables you to ask questions and exchange views before or after each study weekend. There is also a diary tool so that you can download details of the dates and times of the study weekends into Outlook or other calendars.

Additional guidance and support

Visiting and adjunct professors can offer guidance and support outside the study weekends. If you want to, you may submit a written assignment for each module in order to receive feedback on your progress.

In 2010-11, the Institute plans to offer additional evening classes led by local practitioners to focus on particular aspects of the syllabus or past exam questions.

A range of revision events will be held after Easter. By this stage, you will be pulling-together and consolidating the material covered in the separate modules and beginning to focus on the examination. The precise format of teaching in these weeks, and the timing of the sessions, will be determined by the needs of individual students but can be expected to include: supplementary lectures on any aspects of the course students want to go over again; opportunities for one-to-one meetings with the adjunct or visiting professor in each module; and looking at past examination questions.

Facilities at Law House

All teaching takes place at Law House at 1 Seale Street, St Helier (next to the Town Hall). An air-conditioned seminar room is equipped with a smartboard, wi-fi and a printer. Students may book the seminar room for group study when it is not otherwise in use. There is a kitchen with a microwave, tea, coffee and chilled water facilities.

The Law Library, holding books belonging to the Law Society, Royal Court and the Institute, is located on the top floor. This also has wi-fi and a printer. Entry to the building is controlled by key fobs, issued on enrolment.

French language classes

Jersey lawyers need to have a working knowledge of French. Although the study guide for each module provides English translations or explanations of French terminology, any prospective student who has not studied French to at least GCSE standard (or equivalent) should consider taking general French lessons before embarking on the Jersey Law Course.

The module in which an ability to read and understand French is most obviously needed is Immovable Property and Conveyancing. Candidates may be asked to provide advice (in English) on contracts of purchase written in French. The Jersey Law Course includes 10 one-hour classes for groups of about 12 students on French for conveyancing. (Some students choose to have additional private tuition with the Alliance Française or another tutor).

Administration

The Institute of Law's manager, Lori-Ann Foley (lori-ann.foley@lawinstitute.ac.je), is responsible for day-to-day administrative matters. Professor Andrew Le Sueur (andrew.lesueur@lawinstitute.ac.je) is the part-time director of studies. Enquiries from prospective students are welcome. Students have regular opportunities to provide feedback on the course.

Relationship between the Institute of Law and the Board of Examiners

The Institute of Law and the Board of Examiners (established under the Advocates and Solicitors (Jersey) Law 1997) have an arm's length relationship. The 1997 Law permits the Board to co-opt 'members who are experienced in setting and marking examinations in law but who need not be advocates or solicitors'. The visiting professors on the Jersey Law Course have been co-opted. The role of the visiting professors in the assessment process ensures that examination questions reflect the material that has been covered during the course. As previously noted, the Board of Examiners also has a role in formally approving the study guides.

The examinations

You should familiarise yourself with the Advocates and Solicitors (Qualifying Examination) Rules 1997 as amended (www.jerseylaw.je/LawStudents/Legislation/default.aspx). The Rules stipulate that examinations are held in two periods each year: in June-July and September. Each of these periods counts as a separate session. At least two papers must be taken in any session entered. All six papers must be passed within six successive sessions. The Institute has no direct involvement in candidates' enrolment for the exams or their organisation. Candidates should liaise directly with the Board of Examiners if they have any queries (R.Traisnel@gov.je or telephone 01534 441103). The Board of Examiners make the examination results available within six weeks of the exams. This allows students who fail any exams in the June/July session to resit them in the September session.

Fees for 2010-11

The fees for the 2010-11 academic year are unchanged from the previous year.

The fee includes the examination fee for the 'first sit' of each of the six required papers. A further fee may be required by the Board of Examiners for further attempts.

Tutors

Academic prerequisites for qualifying as an advocate or solicitor

Under the relevant legislation (see above) it is necessary for a person seeking to qualify as an advocate or solicitor in Jersey to have either (i) a recognised law degree or (ii) a degree in another subject and a Graduate Diploma in Law **before** taking the Jersey Law Course. For qualification as an advocate it is necessary also to have a professional legal qualification in another jurisdiction (such as being called to the Bar or enrolled as a solicitor in England and Wales).

From September 2010, the Institute of Law will be offering tuition for students studying for a law degree through the University of London External System: please see the Institute's website for further information.

Practical experience

The Advocates and Solicitors (Jersey) Law 1997 requires a person seeking to qualify in Jersey to have been employed in a law office for a specified period of time immediately preceding the person's application to be admitted as a solicitor or advocate in Jersey. For this reason, the Jersey Law Course is normally taken by people who are already employed in a law office in Jersey (so the system is different from that in England and Wales where professional law courses are taken before seeking a training contract or pupillage).

Students with disabilities

The Institute welcomes applications from students with disabilities. Please contact the Institute as early as possible to discuss any special needs.
